Pursuant to Sec. 69.1 (i) Rule XXIII of the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (R.A.) 9184, and in accordance with Department Order No. 28 series of 2024, this Suspension Order is hereby issued against **CABAGIS BUILDERS INC**.

Based on the Approved Consolidated Strike Report, dated May 31, 2024, and posted on the DPWH Intranet on June 10, 2024, this contractor, bearing the PhilGEPS Registration No.20230333490432272063 and located at Tay-ac Lidlidda, Ilocos Sur, Region I, is found to have committed three (3) strikes/offenses of a similar or identical nature within a year, starting from the approval date of the Resolution Recommending the Imposition of Strike One - First Warning.

It is important to emphasize that the above-listed offenses are considered as three (3) separate and distinct acts committed on the same day.

CABAGIS BUILDERS INC. is disqualified from participating in any DPWH bidding processes, effective immediately upon receipt of the Notice of Suspension. This suspension shall remain in effect during any period of reconsideration or appeal until a final decision is rendered by the Office of the Secretary. However, this suspension does not apply to the contractor's participation in procurement activities of other government agencies.

This Order shall take effect immediately.
