**SUBJECT: Issuance of Suspension Order to
VAL ENGINEERING AND
CONSTRUCTION**

Pursuant to Sec. 69.1 (i) Rule XXIII of the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (R.A.) 9184, and in accordance with Department Order No. 28 series of 2024, this Suspension Order is hereby issued against **VAL ENGINEERING AND CONSTRUCTION**.

Based on the Approved Consolidated Strike Report, dated June 30, 2024, and posted on the DPWH Intranet on July 09, 2024, this contractor, bearing the PhilGEPS Registration No. 201811671651128153685 and located at B10 L13 Phase 3B Doña Soledad Subdivision, General Santos City, South Cotabato, is found to have committed three (3) strikes/offenses of a similar or identical nature within a year, starting from the approval date of the Resolution Recommending the Imposition of Strike One - First Warning.

This suspension shall remain in effect during any period of reconsideration or appeal until a final decision is rendered by the Office of the Secretary. However, this suspension does not apply to the contractor's participation in procurement activities of other government agencies.

This Order shall take effect immediately.


