SUBJECT: Approval of Detailed Engineering Design Plan for Dredging Projects

In line with the continuing efforts of this Department to streamline its operations for efficient and expedient service delivery and project implementation, the function of the Secretary to approve and sign dredging plans for flood control purposes, pursuant to P.D. 1067 – Water Code of the Philippines and Joint Memorandum Circular (JMC) No. 1, s. 2019, re: Guidelines on the Issuance of Clearance and/or Permit for Dredging Within Waterways or Other Inland Bodies of Water, shall be delegated following the limits of authority to approve design plans based on the performance of the Regional and District Engineering Offices in the annual Design Audit in accordance with Department Order No. 39, Series of 2023, "Guidelines and Criteria for the Design Audit of DPWH Regional and District Engineering Offices, 2023 Edition".

The delegated authority in the approval and signing of Detailed Engineering Design Plans for dredging projects in accordance with the provisions of JMC No. 1, Series of 2019, will be as prescribed hereunder, unless otherwise revoked/amended:
