

In accordance with Republic Act (R.A) No. 12015 entitled "An Act Creating a District Engineering Office in the Second Legislative District of Davao City, and Appropriating Funds Therefor", the Davao City Sub-District Engineering Office (Sub-DEO) shall be established as a regular DEO, referred to as the Davao City 3<sup>rd</sup> DEO, with its office to be located at the DPWH Depot in Barangay Panacan, Davao City.

The operationalization of the Davao City 3<sup>rd</sup> DEO shall be incorporated into the Department's program, with its funding to be included in the annual General Appropriations Act (GAA).

This Order shall become effective in the RBIA, provided that the above-mentioned DEO has an agency/organizational code and its operationalization shall be subject to applicable laws, rules and regulations.

Thus, all acts and procedures necessary to ensure the immediate and full operationalization of the Davao City 3rd DEO, including its effectivity in the RBIA, should be undertaken in 2024 in preparation for the DPWH Infrastructure Program for FY 2025.

This Order supersedes Department Order No. 155, series of 2024 and other previous issuances to the contrary.
