SUBJECT: RECONSTITUTION OF PUBLIC-PRIVATE PARTNERSHIP (PPP) PRE-QUALIFICATION, BIDS AND AWARDS COMMITTEE (PBAC) FOR THE PROCUREMENT OF PPP PROJECTS

In the exigency of the service and pursuant to Section 61 of the Implementing Rules and Regulations (IRR) of the Republic Act No. 11966 or the PPP Code IRR, the Pre-qualification, Bids, and Awards Committee (PBAC) for PPP Projects is hereby reconstituted for the procurement of PPP Projects in order to expedite and ensure efficient implementation of the PPP Projects. The PBAC shall be composed of the following:

A Technical Working Group (TWG) is also hereby constituted to undertake the preliminary evaluation of the Pre-qualification/eligibility documents and bids (Technical and Financial Proposals) and shall submit the results to the above-stated PPP PBAC for review and recommendation to the Head of Implementing Agency or its Authorized Representative/s. The TWG shall be headed by the PPP Service and shall be composed of representative/s from the BOD, BOC, FS, LS, PS, PrS and PPP Center. The PPP PBAC and/or its TWG may call/invite on any other offices, as may be necessary, in carrying out its functions.

This Order shall take effect immediately and supersedes Special Order No. 209 series of 2023.
