Planning Service (PS)	Review and recommend on the overall plan for the operation and maintenance facilities and management of the tunnel and coordination with NEDA and other concerned entities
Bureau of Maintenance (BOM)	Review and recommend on the maintenance plan of the Road and Tunnel Section of the Project
Public – Service Partnership Service (PPPs)	Review and recommend on the transition to the Private Sector for the operation and maintenance of the Project and coordination with NEDA and PPP Center and other concerned entities.
Bureau of Quality and Safety (BQS)	Review and recommend on road safety design, and other road safety requirements of the project.
Bureau of Design (BOD)	Review and recommend on design standards for the Operation and Maintenance of the Project
DPWH – Region XI	Assist in the coordination to the concerned stakeholders, government agencies and LGUs for the Capacity Development of the Project

The TWG shall undertake the following task, to wit;

1. Ensure better plan for the operation and maintenance facilities and management of the tunnel.
2. Attend necessary meetings & coordination activities related to the project.
3. Coordinate with JICA and other DPWH Officials/Personnel or representative from other concerned agencies and entities to participate and/or provide assistance related to the project.
