To be eligible to bid for this contract, a contractor must meet the following major requirements:

- Registration certificate from SEC, Department of Trade and Industry (DTI) for sole proprietorship, or CDA for cooperatives;
- b. Filipino citizen or 60% Filipino-owned partnership/corporation;
- valid PhilGEPS Registration Certificate (Platinum Membership) (all pages) in accordance with Section 8.5.2
  of the IRR;
- d. Completion of similar contract costing at least 50% of ABC;
- e. Net Financial Contracting Capacity (NFCC) at least equal to the ABC.
