- The DPWH, Iloilo 6th District Engineering Office, through the FY 2025 GAA Basic Education Facilities (BEFF) intends to apply the Approved Budget for the Contract (ABC) of PhP 4,975,000,00 to payments under the contract 25GR0045—CONSTRUCTION OF SCHOOL BUILDING, SUPANGA ELEMENTARY SCHOOL, BRGY. SUPANGA, MUNICIPALITY OF CALINOG, ILOILO. Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The **DPWH, Iloilo 6th District Engineering Office** through its BAC now invites bids for the hereunder Works of the above Contract:

Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Annex II-1.1 B Section II and III.

3. Prospective Bidders should be registered with and classified by the Philippine Contractors Accreditation Board (PCAB) with PCAB License Size Range of at least **Small B (License Category "C and D")**.

Contractors/applicants who wish to participate in this bidding are encouraged to enroll in the DPWH Civil Works Application (CWA) at the DPWH Procurement Service (PrS), 5th Floor, DPWH Bldg., Bonifacio Drive, Port Area, Manila, while those already enrolled shall keep their records current and updated. The Contractor's eligibility to bid on the project will be determined using the DPWH Contractor Profile Eligibility Process (CPEP) and subject to further post-qualification. Information on registration can be obtained from the PrS during working weekdays from 7:00 am to 4:00 pm or at the DPWH website www.dpwh.gov.ph.

- 4. Bidding will be conducted through an open competitive bidding procedure using non-discretionary pass/fail criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act". The contract shall be awarded to the Lowest Calculated Responsive Bidder (LCRB) who was determined as such during post-qualification.
- 5. Interested bidders may obtain further information from the **DPWH**, **Iloilo 6th District Engineering Office**, and inspect the Bidding Documents at the address given below during weekdays, except holidays, from **8:00 a.m. to 5:00 p.m.**
- 6. A complete set of Bidding Documents may be acquired by interested bidders starting May 29, 2025, until 8:30 a.m. of June 18, 2025, from the address below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Php 5,000.00.
- 7. It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS), and the website of the Procuring Entity, provided that bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.
- 8. The **DPWH, Iloilo 6th District Engineering Office** will hold a Pre-Bid Conference on **June 6, 2025 (2:00 p.m.)** at **Bidding Room, DPWH, Iloilo 6th District Engineering Office, Balabag, Dumangas, Iloilo** and/or through webcasting via Facebook Live of DPWH Iloilo 6th DEO BAC Facebook page which shall be open to prospective bidders.
- 9. Bid submission may be done **manually** or **electronically**. However, **bidders should only select one mode of submission**, either manual or electronic. Similar to manual submission, the guidelines for the preparation and submission of an electronic bid are contained in the **Bid Data Sheet** Clause 17.
- Bids must be duly received by the BAC Secretariat at the address below for manual submission or at <u>electronicbids iloilo6@dpwh.gov.ph</u> for electronic submission on or before **June 18**, 2025, 9:00 a.m. Late bids shall not be accepted.
- 11. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **Bid Data Sheet** Clause 15.1.
- 12. Bid opening shall be on **June 18**, **2025**, **9:00 a.m.** or after all bids have been received or recorded at the **Bidding Room**, **DPWH Iloilo 6th District Engineering Office**, **Balabag**, **Dumangas**, **Iloilo**. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below and through webcasting via YouTube Live of **DPWH Iloilo 6th DEO Procurement LS**.

- 13. The **DPWH, Iloilo 6th District Engineering Office** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
