- 1. The Department of Public Works and Highways, Zamboanga del Norte 2<sup>nd</sup> District Engineering Office, through the SR2025-02-006018 FY 2024 RA 11975 EXTENDED /SR2025-03-008870 FY 2024 RA 11975 EXTENDED intends to apply the sum of Eight Hundred Thousand Five Hundred Sixty-one Pesos and Eighty-four Centavos (Php 800,561.84) being the Approved Budget for the Contract (ABC) to payments under the contract for 25JC0114: Repair and Maintenance of National Roads and Bridges (71x Special Maintenance (ROADS) Repair of Damage Drainage Structures along Sindangan Siayan Dumingag Mahayag Road K1922+650.00 K1922+678.00 (S01060MN). Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The Department of Public Works and Highways, Zamboanga del Norte 2<sup>nd</sup> District Engineering Office now invites bids for the hereunder Procurement Project.

Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in **Section II** (Instructions to Bidders).

- 3. Prospective Bidders should be registered with and classified by the Philippine Contractors Accreditation Board (PCAB) with PCAB license size range of at least *Small A* for *General Engineering (GE-2)*, *Flood Control*.
  - Contractors/applicants who wish to participate in this bidding are encouraged to enroll in the DPWH Civil Works Application (CWA) at the DPWH Procurement Service (PrS), 5th Floor, DPWH Bldg., Bonifacio Drive, Port Area, Manila, while those already enrolled shall keep their records current and updated. The Contractor's eligibility to bid on the project will be determined using the DPWH Contractor Profile Eligibility Process (CPEP) and subject to further post qualification. Information on registration can be obtained from the Procurement Service during working weekdays from 7:00 am to 4:00 pm or at the DPWH website www.dpwh.gov.ph.
- 4. Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR), updated as of 19<sup>th</sup> of July 2024, of Republic Act (RA) No. 9184.
- 5. Interested bidders may obtain further information from *Department of Public Works* and Highways, Zamboanga del Norte 2<sup>nd</sup> District Engineering Office and inspect the Bidding Documents at the *Procurement Unit Office*, DPWH ZDN 2<sup>nd</sup> DEO, Sta. Isabel, Dipolog City, Zamboanga Del Norte during weekdays from 8:00 A.M. to 5:00 P.M.
- 6. A complete set of Bidding Documents may be acquired by interested bidders on *May* 30, 2025 from given address and websites below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of *Five Hundred Pesos (Php. 500.00)*. The Procuring Entity shall allow the bidder to present its proof of payment for the fees in person for bids submitted manually or through email specified below for bids submitted electronically.
- 7. The Department of Public Works and Highways, Zamboanga del Norte 2<sup>nd</sup> District Engineering Office will hold a Pre-Bid Conference on June 09, 2025, 9:00 A.M. at Procurement Unit Office, DPWH ZDN 2<sup>nd</sup> DEO, Sta. Isabel, Dipolog City, Zamboanga Del Norte and live-streamed via Youtube: https://www.youtube.com/@DPWH.ZDN2DEO, which shall be open to prospective bidders.
- 8. Bid Submission maybe done **manually** or **electronically**. However, **bidders should only select one mode of submission**, either manual or electronic. Guidelines for the preparation and submission of an electronic bid are contained in **BDS** Clause 17.
- 9. Bids must be duly received by the BAC Secretariat through (i) manual submission at the *Procurement Unit Office*, *DPWH ZDN 2<sup>nd</sup> DEO*, *Sta. Isabel*, *Dipolog City*, *Zamboanga Del Norte*, or (ii) online/electronic submission as indicated below on or before *June 23*, *2025*, *10:00 A.M.* Late bids shall not be accepted.
- 10. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 15.
- 11. Bid opening shall be on *June 23, 2025, 10:00 A.M.* at the *Procurement Unit Office, DPWH ZDN 2<sup>nd</sup> DEO, Sta. Isabel, Dipolog City, Zamboanga Del Norte* and livestreamed *via Youtube: https://www.youtube.com/@DPWH.ZDN2DEO.* Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.

- 12. If at the time of the post-qualification procedure, the BAC verifies that the bidder has any of the deficiencies, enumerated in Section 34.3(b)(ii) of the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184 due to the contractor's fault or negligence, the Procuring Entity shall disqualify the contractor from the award without any right to reimburse fees and incidental cost paid for the procurement of infrastructure contract subject of the Bid.
- 13. The Department of Public Works and Highways, Zamboanga del Norte 2<sup>nd</sup> District Engineering Office reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised Implementing Rules and Regulations (IRR) of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
