DECLARING CANCELLATION OF CONTRACT ID. NO. 250H0150 – IMPROVEMENT OF ROAD INCLUDING DRAINAGE STRUCTURE ALONG PAZ MENDOZA GUAZON ST. (PHASE 1), MANILA CITY

Resolution No. <u>185-2025</u>

WHEREAS, the Department of Public Works and Highways-South Manila District Engineering Office advertised the Invitation to Bid for the above stated Contract at the website of the DPWH and the PhilGEPS and at a conspicuous place at the premises of the Department of Public Works and Highways- South Manila District Engineering Office continuously for seven (7) calendar days starting on February 26, 2025;

WHEREAS, the said project has an Approved Budget of the Contract (ABC) amounting to NINETY SIX MILLION FOUR HUNDRED NINETY NINE THOUSAND SIX HUNDRED THIRTY EIGHT PESOS AND 96/100 (P 96,499,638.96), ONLY;

WHEREAS, the project in the released approved **Special Allotment Release Order** (**SARO**) for Contract ID No. 250H0150 was inconsistent from the title in the Invitation to Bid;

WHEREAS, the project title stated in the approved Special Allotment Release Order (SARO) dated April 24, 2025 was Improvement of Road including Drainage Structure along Paz Mendiola St. (Phase 1), Manila City;

WHEREAS, there's a need for revision of title in the Plans, POW and ABC due to inconsistency of title of project from Improvement of Road including Drainage Structure along Paz Mendoza Guazon St. (Phase 1), Manila City to Improvement of Road including Drainage Structure along Paz Mendiola St. (Phase 1), Manila City;

WHEREAS, the Bids and Awards Committee unanimously agreed to declare a failure of bidding and cancellation of the procurement activities;

WHEREAS, in paragraph C, Section 41.c.i of R.A 9184 states that "Reservation Clause"- The Hope reserves the right to reject and all the bids, declare a failure of bidding, or not award the contract in if for was justifiable reasonable ground where the award of the contract will not redound to the benefit of the GOP (I) if the physical and economic conditions have significantly changed so as to render the project no longer economically, financially or technically feasible, as determined by the HOPE;

NOW, THEREFORE, we, the Members of the Bids and Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED**, that the above-mentioned project to be declared a failure of Bidding and be cancelled.
