
## CONTRACT AGREEMENT

THIS AGREEMENT, made this 8<sup>th</sup> day of May, 2023 by and between the GOVERNMENT OF THE REPUBLIC OF THE PHILIPPINES through the Department of Public Works and Highways Quezon II District Engineering Office (DPWH QUEZON II DEO) represented herein by DEL ROSARIO C. NACA, District Engineer, duly authorized for this purpose, with main office address at Dalahican Road, Lucena City, Quezon hereinafter called the "Procuring Entity"; and WYDERWAYS BUILDERS AND SUPPLIES a single proprietorship/ partnership/ corporation/ Joint Venture organized and existing under and by virtue of Laws of the Republic of the Philippines, with main office address at #21 Juarez St. Barangay V, Lucena City, Quezon, represented herein by PETER E. ANG, General Manager, duly authorized for this purpose, hereinafter called the "Contractor".

WHEREAS, the ENTITY is desirous that the Contractor execute 23DJ0081-CONVERGENCE AND SPECIAL SUPPORT PROGRAM: Basic Infrastructure Program (BIP)-Access Roads and/or Bridges from the National Road/s leading to Major/Strategic Public Buildings/Facilities, Construction of Road, Barangay St. Francis, Tiaong, Quezon (hereinafter **called the "Works,"**) and the Entity has accepted the Bid for Four Million Nine Hundred Thousand Four Hundred Eighty Five Pesos and Eight Centavos Only (PHP 4,900,485.08) by the Contractor for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- 1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
- 2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as part of this Contract Agreement, viz.;
  - a. Philippine Bidding Documents:
    - i. Drawings / Plans;
    - ii. Specifications;
    - iii. Bill of Quantities;



- iv. General and Special Conditions of Contract;
- v. Supplemental or Bid Bulletins, if any;
- b. Winning bidder's bid, including the Eligibility Requirements, Technical and Financial Proposals, and all other documents or statement submitted.

Bid form including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

c. Performance Security.

- d. Notice of Award (NOA) of Contract and the Bidders "conforme" thereto; and
- e. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. <u>Winning bidder agrees</u> that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
- 3. In consideration for the sum of Four Million Nine Hundred Thousand Four Hundred Eighty Five Pesos and Eight Centavos Only (PHP 4,900,485.08) or such other sums as may be ascertained, WYDERWAYS BUILDERS AND SUPPLIES agrees to execute and complete the works (remedying any defects), in accordance with his/her/its Bid.
- The Department of Public Works and Highways Quezon II District Engineering Office (DPWH QUEZON II DEO) agrees to pay the above – mentioned sum in accordance with the terms of the bidding.


