CONTRACT AGREEMENT

THIS AGREEMENT, made this 8<sup>th</sup> day of May, 2023 by and between the GOVERNMENT OF THE REPUBLIC OF THE PHILIPPINES through the Department of Public Works and Highways Quezon II District Engineering Office (DPWH QUEZON II DEO) represented herein by DEL ROSARIO C. NACA, District Engineer, duly authorized for this purpose, with main office address at Dalahican Road, Lucena City, **Quezon hereinafter called the "Procuring Entity";** and WAYCON BUILDERS AND CONSTRUCTION SUPPLY CORP. a single proprietorship/ partnership/ corporation/ Joint Venture organized and existing under and by virtue of Laws of the Republic of the Philippines, with main office address at Narra St. Employees Village, Brgy. Gulang-Gulang, Lucena City, Quezon, represented herein by ROMLEY A. MENDIOLA, Owner/General Manager, duly **authorized for this purpose, hereinafter called the "Contractor"**.

WHEREAS, the ENTITY is desirous that the Contractor execute 23DJ0107- CONVERGENCE AND SPECIAL SUPPORT PROGRAM: Basic Infrastructure Program (BIP)-Multi-Purpose Buildings/Facilities to support Social Services, Construction of Multi-Purpose Building (Evacuation Center), Villa Consuelo Subdivision, Barangay Ibabang Dupay, Lucena City, Quezon (**hereinafter called the "Works,"**) and the Entity has accepted the Bid for Four Million Eight Hundred Fifty One Thousand Pesos Only (PHP 4,851,000.00) by the Contractor for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.

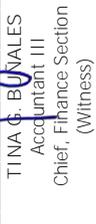

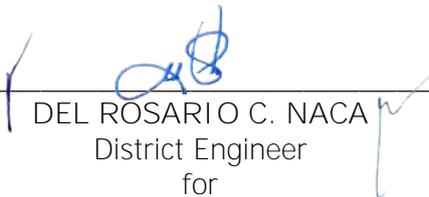

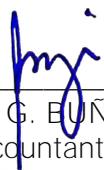
