CONTRACT AGREEMENT

THIS AGREEMENT, made this 8th day of May, 2023 by and between the GOVERNMENT OF THE REPUBLIC OF THE PHILIPPINES through the Department of Public Works and Highways Quezon II District Engineering Office (DPWH QUEZON II DEO) represented herein by DEL ROSARIO C. NACA, District Engineer, duly authorized for this purpose, with main office address at Dalahican Road, Lucena City, Quezon hereinafter called the "Procuring Entity"; and ROMHEAD S.J. BUILDERS & DEV'T INC. a single proprietorship/ partnership/ corporation/ Joint Venture organized and existing under and by virtue of Laws of the Republic of the Philippines, with main office address at 1622 Quezon Avenue Extension, Brgy. Cotta, Lucena City, Quezon, represented herein by ELIZABETH M. EDAÑO, General Manager, duly authorized for this purpose, hereinafter called the "Contractor".

WHEREAS, the ENTITY is desirous that the Contractor execute 23DJ0119-CONVERGENCE AND SPECIAL SUPPORT PROGRAM: Basic Infrastructure Program (BIP)-Access Roads and/or Bridges from the National Road/s leading to Major/Strategic Public Buildings/Facilities, Construction of Riverside Road, in Lucena City, Quezon (hereinafter called the "Works,") and the Entity has accepted the Bid for Nine Million Six Hundred Eighty Two Thousand Two Hundred Pesos Only (PHP 9,682,200.00) by the Contractor for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:


