Cavit, Laoag City** (hereinafter called the "Entity") and **11-16 CONSTRUCTION of Mac Arthur Highway San Vicente Apalit 2016, Apalit, Pampanga** (hereinafter called the "Contractor").

  - d. Notice of Award of Contract and the Bidder's conforme thereto: and
  - e. Other contract documents that maybe required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution such as the Notice to Proceed, Variation Orders and Warranty Security shall likewise form part of the Contract.
