CONTRACT AGREEMENT

THIS AGREEMENT, made this 20 MAR 2025, between **Department of Public Works and Highways – Ilocos Norte First District Engineering Office (DPWH-INFDEO)** of **Airport Avenue, Brgy. Cavit, Laoag City** (hereinafter called the "Entity") and **BJMJB CONSTRUCTION & SUPPLY** of **B42 L27 Road 25 Cogeo Village, Bagong Nayan, Antipolo City** (hereinafter called the "Contractor").

WHEREAS, the Entity is desirous that the Contractor **CONVERGENCE AND SPECIAL SUPPORT PROGRAM - SUSTAINABLE INFRASTRUCTURE PROJECTS ALLEVIATING GAPS (SIPAG) - ACCESS ROADS AND/OR BRIDGES FROM THE NATIONAL ROAD/S LEADING TO MAJOR/STRATEGIC PUBLIC BUILDINGS/FACILITIES - CONSTRUCTION OF ROAD, BARANGAY 37 CALAYAB, LAOAG CITY, ILOCOS NORTE** with Contract ID **25AA0240** (hereinafter called "the Works") and the Entity has accepted the Bid for **FOUR MILLION SEVEN HUNDRED FORTY SEVEN THOUSAND THREE HUNDRED EIGHTY NINE PESOS & 92/100 ONLY (PHP 4,747,389.92)** by the Contractor for the execution and completion of such Works and remedying of any defects therein.

 - iv. General and Special Conditions of Contract;
 - v. Supplemental of Bid Bulletins, if any;
 - b. Winning bidder's including the Eligibility Requirements, Technical and Financial Proposals, and all other documents or statements submitted;
 - c. Performance Security;
 - d. Notice of Award of Contract and the Bidder's conforme thereto: and
 - e. Other contract documents that maybe required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution such as the Notice to Proceed, Variation Orders and Warranty Security shall likewise form part of the Contract.
