No. 51-B, Nangalisan West, Laoag City, Ilocos Norte** (hereinafter called the "Contractor").

  - e. Other contract documents that maybe required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution such
