Cavit, Laoag City** (hereinafter called the "Entity") and **NORTH TECH BUILDERS AND CONSTRUCTION SUPPLY** of **Brgy. 7, Sucsuquen, Piddig, Ilocos Norte** (hereinafter called the "Contractor")✓


