Cavit, Laoag City** (hereinafter called the "Entity") and **RED JEWEL BUILDERS** of **Brgy. 21, San Marcos, Sarrat, Ilocos Norte** (hereinafter called the "Contractor").

WHEREAS, the Entity is desirous that the Contractor execute **CONVERGENCE AND SPECIAL SUPPORT PROGRAM - SUSTAINABLE INFRASTRUCTURE PROJECTS ALLEVIATING GAPS (SIPAG) - ACCESS ROADS AND/OR BRIDGES FROM THE NATIONAL ROAD/S LEADING TO MAJOR/STRATEGIC PUBLIC BUILDINGS/FACILITIES - REHABILITATION OF ROAD, BARANGAY 7 SAN MANUEL, SARRAT, ILOCOS NORTE**, with Contract ID **25AA0310**, (hereinafter called "the Works") and the Entity has accepted the Bid for **FOUR MILLION SEVEN HUNDRED FORTY SIX THOUSAND EIGHT HUNDRED THIRTY THREE PESOS & 72/100 ONLY (PHP 4,746,833.72)**, by the Contractor for the execution and completion of such Works and remedying of any defects therein.

 - d. Notice of Award of Contract and the Bidder's conforme thereto: and
 - e. Other contract documents that maybe required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution such
