DE GUZMAN**, **OIC - District Engineer**, duly authorized for this purpose, with main office address at **DPWH-Cagayan Third District Engineering Office**, **Tuguegarao City**, hereinafter referred to as the **"PROCURING ENTITY"**;

RIXS ENGINEERING DESIGN SERVICES single proprietorship/ partnership/ corporation/joint venture organized and existing under and by virtue of laws of the Republic of the Philippines, with main office address at **Lingan St., Brgy. Andarayan North, Solana, Cagayan**. Represented herein by **RICHARD B. UBIÑA** duly authorized for this purpose hereinafter referred to as the **"CONTRACTOR;**"

WITNESSETH:
