WHEREAS, the Entity is desirous that the Contractor execute **25CE0271**
Asset Preservation Program - Preventive Maintenance - Tertiary Roads
Guimba - Talugtug - Umingan Rd - KO160 + 080 - KO163 + 080
(hereinafter called "the Works") and the Entity has accepted the Bid for
ONE HUNDRED FORTY THREE MILLION THREE HUNDRED THREE THOUSAND
ONE HUNDRED EIGHTY THREE

AND 27/100 PESOS ONLY (Php 143,303,183.27)
by the Contractor for the execution and completion of such Works and the remedying of
any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.

- v. Supplemental or Bid Bulletins, if any;

- b. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

e. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. **Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.**

3. In consideration for the sum of ONE HUNDRED FORTY THREE MILLION THREE HUNDRED THREE THOUSAND ONE HUNDRED EIGHTY THREE AND 27/100 PESOS (Php 143,303,183.27) or such other sums as may be ascertained,
