## CONTRACT AGREEMENT

THIS AGREEMENT, made this APR 04 2025 between **GOVERNMENT OF THE REPUBLIC OF THE PHILIPPINES** through the **Department of Public Works and Highways (DPWH)** represented herein by **DONNIE D. CUNA**, District Engineer, duly authorized for this purpose, with main office address at DPWH Cavite 3<sup>rd</sup> District Engineering Office, Brgy. Lantic, Carmona City, Cavite (hereinafter called the "**ENTITY**") and **I & E CONSTRUCTION CORPORATION** with main office address at Lot 7 & 8 Blk 10 BF Homes Martin Ville, Manuyo II, Las Piñas City, represented herein by **JOSELITO C. IMBAO**, Authorized Managing Officer, duly authorized for this purpose, (hereinafter called the "**CONTRACTOR**").

WHEREAS, the Entity is desirous that the Contractor execute under **Contract ID No. 25DQ0048: ORGANIZATIONAL OUTCOME 2 : Protect Lives and Properties Against Major Floods - Flood Management Program - Construction/ Rehabilitation of Flood Mitigation Facilities within Major River Basins and Principal Rivers - Construction of Slope Protection along Julian River, Phase 2, Barangay Zone I, Dasmariñas City, Cavite** (hereinafter called "the Works") and the Entity has accepted the Bid for **Ninety Three Million Six Hundred Four Thousand Sixty and 64/100 (PHP 93,604,060.64) Philippine Pesos** by the Contractor for the execution and completion of such Works and the remedying of any defects therein.

### NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this **AGREEMENT**, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.

- d. Notice of Award of Contract and the Bidder's conforme thereto; and
- e. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. **Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.**

3. In consideration for the sum of **Ninety Three Million Six Hundred Four Thousand Sixty and 64/100 (PHP 93,604,060.64) Philippine Pesos** or such other sums as may be ascertained, **I & E CONSTRUCTION CORPORATION** agrees to execute and complete the Works in accordance with his/her/its Bid.

4. The Department of Public Works and Highways (DPWH) agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
