- Contractor's All Risk Insurance (CARI)
- Latest Income Tax and Business Returns duly stamped and received by BIR and duly validated with the tax payments made. Tax Clearance from the BIR to prove full and timely payment of taxes.
- For a local contractor, Certification under oath stating that the Contractor is free and clean of all tax liabilities.
- For a foreign bidder, valid PCAB License and Registration for the type and cost of the contract to be bid, when the Treaty or International or Executive Agreement expressly allows submission of the PCAB License and Registration for the type and cost of the contract at hand as a pre-condition to the NOA.
- Integrity Pledge under Department Order No. 86, series of 2013.
