CONTRACT AGREEMENT

THIS AGREEMENT, made this 13th day of June, 2025 between **Department of Public Works and Highways**, with offices address at Sindalan, City of San Fernando, Pampanga, represented by **ROSELLER A. TOLENTINO - Regional Director** (hereinafter called the "Entity") and **CELSO C. FERRER CONSTRUCTION CORPORATION**, with office address at 0756 Mampulog, Bitas, Cabanatuan City, represented by **CELSO C. FERRER - Owner/General Manager** (hereinafter called the "Contractor").

WHEREAS, the Entity is desirous that the Contractor execute **25C00492: Asset Preservation Program - Preventive Maintenance - Primary Roads - Maharlika Highway, Province of Nueva Ecija** (hereinafter called "the Works") and the Entity has accepted the Bid for **Thirty Six Million Seven Hundred Twenty Seven Thousand One Hundred Sixteen Pesos and 18/100 centavos only (P 36,727,116.18)** by the Contractor for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESS AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meaning as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act. No. 9184 shall be deemed to form and be read and construed as part of this Agreement, viz.:
 - a. Philippine Bidding Documents (PBDs);
 - i. Drawings/Plans;
 - ii. Specifications;
 - iii. Bill of Quantities;
 - iv. General and Special Conditions of Contract;
 - v. Supplemental of Bid Bulletins, if any;
 - b. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals (Bid Evaluation – as calculated, if applicable) and all other documents or statements submitted;

 - d. Notice of Award of Contract and the Bidder's conforme thereto; and
 - e. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. **Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.**
3. In consideration for the sum of **Thirty Six Million Seven Hundred Twenty Seven Thousand One Hundred Sixteen Pesos and 18/100 centavos only (P 36,727,116.18)** or such other sums as may be ascertained, **CELSO C. FERRER CONSTRUCTION CORPORATION**, agrees to implement and complete the construction of the Asset Preservation Program - Preventive Maintenance - Primary Roads - Maharlika Highway, Province of Nueva Ecija within **Sixty (60) calendar days** in accordance with his/her/its Bid.
 4. The **DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.




