**WHEREAS**, the *DPWH-Cagayan 2<sup>nd</sup> District Engineering Office* advertised the Invitation to Bid for the above stated Contract and posted the same at the websites of the DPWH and the PhilGEPS and at a conspicuous place at the premises of the *DPWH-Cagayan 2<sup>nd</sup> District Engineering Office* continuously starting *March 05, 2025*;

**WHEREAS**, in response to the Invitation to Bid for the above-mentioned contract, the BAC through the BAC Secretariat received **two (2)** bid/s for the contract;

**WHEREAS**, on *March 26, 2025*, the BAC conducted the Public Bidding of the stated contract and as per result of the evaluation of the Legal and Financial Components of their Technical Proposal and results of the Electronic Eligibility Processing, the bidder/s was/were found eligible to participate in the public bidding namely *Shasha's Construction & Supplies, Oliva Design and Construction, , ;*

**WHEREAS**, the bid/s from the eligible bidder/s, passed the preliminary examination of the Technical and Financial Proposals based on the presence of the submitted documents as against the checklist of required documents and, consequently, the BAC read and recorded the bid/s as follows:

**WHEREAS**, the BAC, with the assistance of its Technical Working Group, conducted the detailed evaluation of the abovementioned bids on *April 02, 2025*, which resulted in the following bid/s as calculated:

**WHEREAS**, upon verification of the eligibility documents of the bidder who posted the lowest calculated bid, it was found that Shasha's Construction and Supplies has Financial Statement for 2024 which was stamped and received by the BIR but the PhilGEPS Registration Certificate it was not updated prior to the deadline of submission of bids, thus post-disqualified due to submission of PhilGEPS Registration Certificate containing non-current eligibility document; the BAC through its TWG proceeded with the post-qualification to the next bidder;


**WHEREAS**, upon post-qualification, validation and verification of the eligibility, technical and financial documents submitted by *Oliva Design and Construction*, the BAC found its bid responsive and, therefore, the bidder is post-qualified;

**NOW, THEREFORE**, we, the Members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED:

- a) To declare ***Oliva Design and Construction***, as the Bidder with the **Single Calculated Responsive Bid** for the abovementioned Contract; and
- b) To recommend to the District Engineer for approval, the award of the said Contract to *Oliva Design and Construction* with the Single Calculated Responsive Bid at its total submitted bid or total Calculated Bid, whichever is lower, in the amount of **Four Million Nine Hundred Thirty Four Thousand Two Hundred Sixty Five Pesos and 52/100 (Php4,934,265.52)** for a duration of one hundred thirteen (113) Calendar Days.
