**WHEREAS**, the DPWH-Cagayan 3<sup>rd</sup> District Engineering Office advertised/posted the Invitation to Bid for the above-stated project on April 15, 2025 at the DPWH and PhilGEPS website and at a conspicuous place within the premises of the DPWH-CTDEO for seven (7) calendar days;

**WHEREAS**, in response to the said Invitation, two (2) interested bidders purchased bidding documents from April 15, 2025 until the deadline for the submission of bids, to wit:

**WHEREAS**, the prospective bidders KNI88 HARDWARE AND CONSTRUCTION SUPPLY and MAIDA'S CONSTRUCTION, submitted their respective bids on May 07, 2025 on the prescribed place and time;

**WHEREAS**, during the Bid Opening, the BAC through the Secretariat read the generated result of Contractor's Electronic Eligibility screening using the DPWH Civil Works Application (CWA) to check the bidders' compliance as to legal, financial, and technical capabilities, simultaneously, preliminary examination was conducted on the technical envelopes of the two (2) bidders, using a non-discretionary "pass/fail" criterion (presence or absence of required documents) against the checklist of requirements as stipulated in the bidding documents;
