WHEREAS, the DPWH-Cagayan 3rd District Engineering Office advertised/posted the Invitation to Bid for the above-stated project on May 27, 2025 at the DPWH and PhilGEPS website and at a conspicuous place within the premises of the DPWH-CTDEO for seven (7) calendar days;

WHEREAS, in response to the said Invitation, two (2) interested bidders purchased bidding documents from May 27, 2025 until the deadline for the submission of bids, to wit:

- 1. DOUBLE J1908 CONSTRUCTION
- 2. JC PALOMO CONSTRUCTION & CONSTRUCTION SUPPLY

WHEREAS, the prospective bidders DOUBLE J1908 CONSTRUCTION and JC PALOMO CONSTRUCTION & CONSTRUCTION SUPPLY, submitted their respective bids on June 16, 2025 on the prescribed place and time;

WHEREAS, during the Bid Opening, the BAC through the Secretariat read the generated result of Contractor's Electronic Eligibility screening using the DPWH Civil Works Application (CWA) to check the bidders' compliance as to legal, financial, and technical capabilities, simultaneously, preliminary examination was conducted on the technical envelopes of the two (2) bidders, using a non-discretionary "pass/fail" criterion (presence or absence of required documents) against the checklist of requirements as stipulated in the bidding documents:
