WHEREAS, in response to the said Invitation, the BAC received one (1) bid for the Contract as of the deadline for the submission of Bids on July 28, 2025 at 10:00 a.m.;

WHEREAS, on July 28, 2025, the BAC conducted opened and undertook the Preliminary Examination of the Technical Components of the Bids, and found that one (1) Bid passed and no Bidders failed the Preliminary Examination, as follows:


