WHEREAS, in response to the said Invitation, the BAC received **One (1)** bid for the Contract on the deadline for the Submission of Bids on May 15, 2025;

WHEREAS, on May 15, 2025, the BAC conducted, opened and undertook the Preliminary Examination of the Technical Component of the Bid, and found that the Bidder passed the Preliminary Examination, as follows:

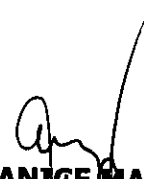
NOW, THEREFORE, we, the Members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED:

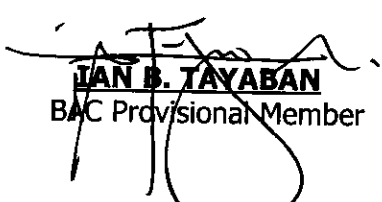
- a) To declare **MSMV Construction and Supply** as the Bidder with the Single Calculated Responsive Bid (SCRB) for the abovementioned Contract; and

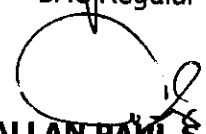
