## **BAC RESOLUTION DECLARING FAILURE OF BIDDING**

RESOLUTION NO. 31, Series 2025

WHEREAS, the DPWH - Baguio City District Engineering Office advertised the Re-Invitation to Bid for the above-stated contract and posted at the DPWH Website, Phil-Geps, and at a conspicuous place at the premises of DPWH-BCDEO continuously from April 15, 2025 to May 15, 2025;

WHEREAS, in response to the said Re-Invitation to Bid, only HAIGHT's Construction purchased Bidding Documents;

WHEREAS, on March 10, 20May 15, 2025, before 10:00 A.M., the BAC received the bid of HAIGHT's Construction. Prior to the time of bid opening, the BAC thru the Secretariat processed the Electronic Contractor's Eligibility and was rated "ELIGIBLE". Thus, the BAC conducted the preliminary examination of the technical bid to determine solely the "presence or absence" of each of the required documents comprising the bid as required against the checklist and was rated "PASSED";

WHEREAS, the financial bid was subjected to preliminary examination as to compliance with the requirements of the project as stipulated in the bidding documents and was rated "PASSED", hence, his bid was read and recorded as follows:

WHEREAS, the detailed bid evaluation as to completeness and correctness on the arithmetical calculations for the financial component was conducted on May 20, 2025 in accordance with Section 32.2.1 of Rule IX of the Revised IRR of RA 9184;

WHEREAS, after the bid evaluation, it was found out that HAIGHT's Construction is considered as a Single Calculated Bidder and his bid as calculated and as read in the amount of Nine Million Six Hundred Two Thousand Three Hundred Pesos (Php9,602,300.00) are the same;

WHEREAS, the bid of HAIGHT's Construction being considered as the Single Calculated Bidder was subjected to post-qualification and after careful examination, validation and verification of all his eligibilities (Technical and Financial Documents), the BAC - TWG found its bid "Non-Responsive" and therefore his firm is post-disqualified on the ground that the pledged equipment for the above cited Contract such as Dumptruck with Plate Number NAN 4830 was already pledged with Contract ID No. 25PD110 under KANE Construction;

WHEREAS, the BAC notified HAIGHT's Construction of its post-disqualification on May 30, 2025 and was officially sent thru his E-Mail Address on June 4, 2025;

WHEREAS, HAIGHT'S Construction did not file his Motion for Reconsideration (MR) within the required reglementary period of three (3) calendar days upon the receipt of the postdisqualification as provided for under Rule XVII, Section 55.1 of the Revised IRR of RA 9184. Hence, his post-disqualification had become final;
