The Department of Public Works and Highways (DPWH), Davao City II District Engineering Office, through its Implementing Unit, Planning and Design Section, has received financing (herein called "funds") from the Government of the Philippines (hereinafter called the "funding source") towards the cost of the Consultancy Services for the Geotechnical Exploration for A) Construction of Concrete Revetment along Mintal Creek, Sitio Basak (Mintal Section), Sta. 0+000-Sta. 0+750, Davao City B) Construction of Cut-Off Wall at Calinan Creek, Sta. 0+000-Sta. 0+250, Barangay Calinan Poblacion, Calinan District, Davao City. The Procuring Entity intends to apply a portion of the funds in the amount of PhP650,000.00, including 5% contingency, being the Approved Budget for the Contract (ABC) to eligible payments under the contract for the Consultancy Services for the Geotechnical Exploration for A) Construction of Concrete Revetment along Mintal Creek, Sitio Basak (Mintal Section), Sta. 0+000-Sta. 0+750, Davao City B) Construction of Cut-Off Wall at Calinan Creek, Sta. 0+000-Sta. 0+250, Barangay Calinan Poblacion, Calinan District, Davao City for which this Bidding Documents is issued.

With the approval of Resolution No. CS-2024-0010 Recommending the Use of Negotiated Procurement (Small Value Procurement) for the above-mentioned project by the District Engineer of Davao City II District Engineering Office on January 15, 2024, we are requesting you to submit one (1) original and one (1) copy of Technical and Financial Proposals for the said services.
