DPWH-Regional Office I with main office address at Aguila Road, City of San Fernando, La Union, represented herein by REGIONAL DIRECTOR RONNEL M. TAN, hereinafter called the "Entity,"

and


Anchor's Geotechnical Consulting Service with main office address at 12 Dalsol Street, GSIS Village Brgy. Sangandaan, Quezon City, represented herein by MS. ALOHA A. VITUG, hereinafter called the "Consultant."

WHEREAS, the Entity is desirous that the Consultant execute the Consultancy Service for the Conduct of Geotechnical Investigation of Various Flood Control Projects in Ilocos Sur with contract ID 25CSA052 (hereinafter called "the Works"), and the Entity has accepted the bid for One Million Four Hundred Ninety Thousand Pesos (Php1,490,000.00) by the Consultant for the execution and completion of such Consulting Services and the remedying of any defects therein.

WHEREAS, the whole of the works of the Project as covered by this Contract shall be completed within the period of Fifteen (15) CALENDAR DAYS, reckoned from the Effectivity Date of Contract, based on the Notice to proceed (NTP) to be issued by the EMPLOYER to the CONTRACTOR.

 - (k) Other contract documents that may be required by existing laws and/or the Entity.

3. In consideration of the payments to be made by the Entity to the Consultant as hereinafter mentioned, the Consultant hereby covenants with the Entity to execute and complete the Consulting Services and remedy any defects therein in conformity with the provisions of this Consultant in all respects.


