THIS AGREEMENT, made this ____ day of JUN 10 2025, by and between:

DPWH-Regional Office I with main office address at Aguila Road, City of San Fernando, La Union, represented herein by REGIONAL DIRECTOR RONNEL M. TAN, hereinafter called the "Entity,"

and

Accugeo Construction Materials Testing Center with main office address at 175 Kamias Extn. Road, Brgy. Sikatuna Village, Quezon City, represented herein by MS. MARJORY P. AVORQUE, hereinafter called the "Consultant."

WHEREAS, the Entity is desirous that the Consultant execute the Consultancy Service for the Conduct of Geotechnical Investigation of Various Flood Control Projects in Pangasinan with contract ID 25CSA053 (hereinafter called "the Works"), and the Entity has accepted the bid for Two Million Five Hundred Ninety Seven Thousand Forty Pesos and Ninety Five Centavos (Php2,597,040.95) by the Consultant for the execution and completion of such Consulting Services and the remedying of any defects therein.

- (i) Performance Security;
- (j) Notice of Award of Contract and the Bidder's conforme thereto;
- (k) Other contract documents that may be required by existing laws and/or the Entity.

In consideration of the payments to be made by the Entity to the Consultant as hereinafter mentioned, the Consultant hereby covenants with the Entity to execute and complete the Consulting Services and remedy any defects therein in conformity with the provisions of this Consultant in all respects.
