CONTRACT AGREEMENT

KNOW ALL MEN BY THESE PRESENTS:

This **CONTRACT AGREEMENT**, made this 11th 05 2015 by and between:

The **GOVERNMENT OF THE REPUBLIC OF THE PHILIPPINES** through the **Department of Public Works and Highways (DPWH)** represented herein by **Engr. GIL B. LORENZO, District Engineer**, duly authorized for this purpose, with main office address at DPWH- La Union Second District Engineering Office, Brgy. San Joaquin Sur, La Union, hereinafter referred to as the "**PROCURING ENTITY**";

DBADSUARA ENGINEERING CONSULTANCY, a Sole Proprietor organized and existing under and by virtue of laws of the Republic of the Philippines, with main office address at Rm 209 2/F Saunterfield Bldg., Ortigas Ave. Ext., Brgy. Sto. Niño, Cainta, Rizal, represented herein by **DON B. ADSUARA**, duly authorized for this purpose, hereinafter referred to as the "**CONSULTANT**";

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

The PROCURING ENTITY hereby covenants to pay the CONSULTANT in consideration of the execution and completion of the Services, the Contract Price or such other sum as may become payable under the provisions of this **CONTRACT AGREEMENT** at the times and in the manner prescribed by this **CONTRACT AGREEMENT**.


