**GROUNDWORKZ GEOTECHNICAL TESTING SERVICES**, a single proprietorship / partnership / corporation / joint venture organized and existing under and by virtue of laws of the Republic of the Philippines, with main office address at Urdaneta City, Pangasinan represented herein by **MR. NICK C. MAMARIL** duly authorized for this purpose, hereinafter referred to as the "**CONTRACTOR**";

WHEREAS, the Entity is desirous that the Contractor execute **25CSAH03 Conduct of Soil Exploration and/or Geotechnical Investigation for various Flood Control Projects in 2nd Legislative District of Pangasinan**, hereinafter called "the Works" and the Entity has accepted the Bid for **Six Hundred Fifteen Thousand Fifteen Pesos Only (Php 615,015.00)** by the Contractor for the Execution and completion of such Works and the remedying of any defects therein.

- b. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- c. Performance Security;
- d. Notice of Award of Contract and the Bidder's conforme thereto; and
- e. Other contract documents that may be required by the existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
