Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or egulations of which grant similar rights or previleges to Filipino citizens, pursuant to RA No. 5183.

Bids must be duly received by the BAC Secretariat through *manual submission* at the *Procurement Unit Office, Paulog, Ligao City*, on or before *January 23, 2024* at **10:00 AM**. Late bids shall not be accepted.

All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 14.

Bid Opening shall be on *January 23, 2024* at *10:30 AM*, at the *Procurement Unit Office*, *Paulog*, *Ligao City*. Bids will be opened in the presence of the bidders' representative/s who choose to attend the activity.

Prospective bidders are advised that this Office is implementing D.O. 17 series of 2015 - 3-strike policy in the procurement of contracts for infrastructure works, goods, and consulting services.
