## **INVITATION TO BID**

## 23GE00039 - ACQUISITION OF JANITORIAL SERVICES FOR DPWH MIMAROPA **REGION IV-B FOR CY-2024**

- The Department of Public Works and Highways (DPWH) Region IV-B, through the CY-2023 EAO 1. Extended Funds intends to apply the sum of Six Million One Hundred Eighty-Nine Thousand Sixty-Two Pesos and 04/100 [Php6,189,062.04] only, being the Approved Budget for the Contract (ABC) for the payment under contract, Acquisition of Janitorial Services for DPWH MIMAROPA Region IV-B for CY-2024, with Contract ID 23GE00039. Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The Department of Public Works and Highways (DPWH) Region IV-B now invites bids for the above Procurement Projects. Bidders should have completed, within five (5) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
- Bidding will be conducted through open competitive bidding procedures using a non-discretionary 3. "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
  - Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.
- 4. Prospective Bidders may obtain further information from *Department of Public Works and Highways* (DPWH) Region IV-B and inspect the Bidding Documents at the address given below during Monday to Friday from 7:00 a.m. to 4:00 p.m.
- 5. A complete set of Bidding Documents may be acquired by interested Bidders on January 5, 2024 to **January 24, 2024** from the given address and website(s) below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of TEN THOUSAND PESOS only (Php10,000.00).
- 6. The Department of Public Works and Highways (DPWH) Region IV-B will hold a Pre-Bid Conference on January 12, 2024 9:00 A.M. at Conference Room, DPWH Region IV-A, EDSA, *Ouezon City*, which shall be open to prospective bidders.
- 7. Bids must be duly received by the BAC Secretariat through (i) manual submission at the office address indicated below, on or before January 24, 2024 9:00A.M. Late bids shall not be accepted.
- All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount 8. stated in ITB Clause 14.

- 9. Bid opening shall be on *January 24, 2024, 9:00A.M.* at the given address below Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
- 10. The *Department of Public Works and Highways (DPWH) Region IV-B* reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
