- 1. The DPWH-Pampanga 3rd District Engineering Office, through FY 2024 RA 11975 REG 2024 CURRENT SR2024-05-016562 MOOE intends to apply the sum of ₱ 5,397,562.40 being the Approved Budget for the Contract (ABC) to payments for the contract Contract ID No. 24GCI0008 Procurement of Various Construction Supply for use in Patching Potholes, Sealing of Cracks, Repainting of Faded Markings & Bridge Structures and Installation of Bridge Safety Devices along Various Bridges of 1st District of Pampanga at DPWH Pampanga 3rd DEO. Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The **DPWH-Pampanga 3rd District Engineering** Office now invites bids for the above Procurement Project. Delivery of the Goods is required within 30 calendar days upon approval of Purchase Order (P.O.). Bidders should have completed, within 10 years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders.
- 3. Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
 - a. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty (60%) interest or outstanding capital stock belongings to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.
- 4. Prospective bidders may obtain further information from *DPWH-Pampanga 3rd District Engineering Office* and inspect the Bidding Documents at the address given below during *Monday to Friday, between 8:00 A.M. to 5:00 P.M.*
- 5. A complete set of Bidding Documents may be acquired by interested Bidders on <u>June 22, 2024</u> to <u>July 12, 2024</u> from the address and website(s) below, and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of <u>₱ 10,000.00</u>. The Procuring Entity shall allow the bidder to present its proof of payment for the fees in person, by facsimile, or through electronic means.
