The Department of Public Works and Highway Tacloban City DEO, through Fund of **EAO CY 2024** intends to apply the sum of **Nine Million Pesos Only (Php9,000,000.00)** being the Approved, Budget for the Contract (ABC) to payments under the contract for **SUPPLY/PROCUREMENT OF UNMANNED SURFACE VESSEL (USV) (SURVEYING INSTRUMENT) FOR THE USE OF PLANNING AND DESIGN SECTION, DPWH-TCDEO, NEW BUS TERMINAL, BRGY. 91, ABUCAY, TACLOBAN CITY** with **Contract ID No. 24GIM0009**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The Department of Public Works and Highway Tacloban City DEO now invites bids for Procurement Project. Procurement of Goods is required by **Thirty (30) C.D.** Bidders should have completed, within **the last two (2) years** from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.
