




## INVITATION TO BID FOR

**25GBJ16 – Repair/Maintenance of Various National Roads (Selected Concrete Reblocking) Aritao-Quirino Road (S00883LZ), K0257+300 - K0290+527 (Intermittent Section), Bambang-Kasibu Road, K0281+950 - K0285+322.50 (Intermittent Section), Jct Nat'l Rd-Bitnong-Balance-NV Bdry. Rd (S06021LZ), K0259+260 - K0271+777 (Intermittent Section)**

1. The **DPWH - Nueva Vizcaya 2nd District Engineering Office**, through the **GAA FY 2025** intends to apply the sum of **₱1,197,609.00** being the Approved Budget for the Contract (ABC) to payments under the contract for **25GBJ16 – Repair/Maintenance of Various National Roads (Selected Concrete Reblocking) Aritao-Quirino Road (S00883LZ), K0257+300 - K0290+527 (Intermittent Section), Bambang-Kasibu Road, K0281+950 - K0285+322.50 (Intermittent Section), Jct Nat'l Rd-Bitnong-Balance-NV Bdry. Rd (S06021LZ), K0259+260 - K0271+777 (Intermittent Section), Various Roads within Nueva Vizcaya 2nd DEO Jurisdiction**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The **DPWH - Nueva Vizcaya 2nd District Engineering Office** now invites bids for the above Procurement of Goods. Contract duration of Services/Goods is required **14 calendar days**. Bidder should have completed, within **One (1) Year** from the date of submission and receipt of bids, a contract similar to the project. The description of an eligible bidder is contained in the Bidding Documents, particularly in Section II. (Instruction to bidders)
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".  
  
Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.
4. Prospective bidders may obtain further information from **Department of Public Works and Highways - Nueva Vizcaya 2<sup>nd</sup> District Engineering Office**, and inspect the Bidding Documents at the address given below **from 8:00 am to 5:00 pm (Mondays to Fridays)**
5. A complete set of Bidding Documents may be acquired by interested Bidders on **August 05, 2025 to August 27, 2025** from the given address and website(s) below, and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **Five Thousand Pesos (₱ 5,000.00)**. The Procuring Entity shall allow the bidder to present its proof of payment for the fees in person.
6. The **DPWH - Nueva Vizcaya 2nd District Engineering Office** will hold a Pre-Bid Conference on **August 12, 2025 (9:00 AM)** at **Conference Room, DPWH Nueva Vizcaya 2<sup>nd</sup> DEO, Malasin, Dupax del Norte, Nueva Vizcaya**, and/or through webcasting via YouTube Channel (**DPWH Nueva Vizcaya 2nd DEO Procurement Livestream**) which shall be open to all interested parties. Interested parties are encouraged to send their representative to attend the Pre-Bid Conference.
7. Bids must be duly received by the BAC Secretariat for manual submission at the **Conference Room, DPWH Nueva Vizcaya 2nd District Engineering Office, Malasin, Dupax del Norte, Nueva Vizcaya** on or before **9:00am of August 27, 2025**. Late bids shall not be accepted.
