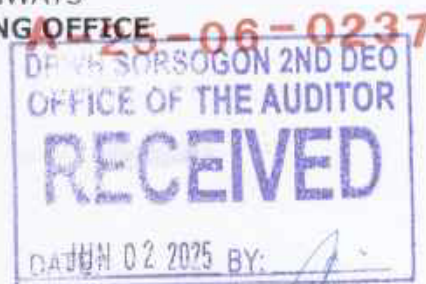

The Department of Public Works and Highways (DPWH) Sorsogon Second District Engineering Office, (SSDEO) Payawin, Gubat, Sorsogon through its Bids and Awards Committee (BAC), invites suppliers to submit bids for the following Contract(s):

The BAC is conducting the public bidding for this Contract in accordance with RA 9184 and its Implementing Rules and Regulations.

Bidders should have completed, within five (5) years from the date of submission and receipt of bids, a contract similar to the Project whose values must be at least equal to 25% of the ABC. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II, Instructions to Bidders (DPM Vol. IV).

To be eligible to bid for this Contract, a supplier must meet the following major requirements:

- (a) Registration certificate from SEC, Department of Trade and Industry (DTI) for sole proprietorship, or CDA for cooperatives;
- (b) G-EPS Registration Certificate – updated Annex "A"
- (c) Mayor's/Business permit issued by the city or municipality where the principal place of business of the prospective bidder is located or the equivalent document for exclusive economic zones or areas;
- (d) Tax clearance per Executive Order 398, Series of 2005, as finally reviewed and approved by the BIR;
- (e) Filipino citizen or 60% Filipino-owned partnership/corporation;
- (f) Completion of a similar contract costing at least 25% of the ABC within five (5) years; and
- (g) Net Financial Contracting Capacity (NFCC) at least equal to the ABC or in lieu of the NFCC computation, a committed line of credit (CLC) specific to the contract to be bid from a universal or commercial bank.

The DPWH will use non-discretionary "pass/fail" criteria in the eligibility check, preliminary examination of bids, evaluation of bids, post-qualification, and award.


