The Department of Public Works and Highways Regional Office VII, through the **FY 2025 RA 11639 Regular 2025 Current** intends to apply the sum of **Php 1,500,727.83** being the Approved Budget for the Contract (ABC) to payments under the contract for **Supply, Delivery and Installation of Ceiling, Hardware, Electrical & Painting Materials for the Repair/Rehabilitation of New Ceiling & Lightings of 2-Units RES Building, RO VII, V. Sotto, Cebu City Quarters, with Contract Id No. 25GH00009; P.R. # 2025-06-0176 dtd. 06-16-2025**. Bids received in excess of the ABC shall be automatically rejected at bid opening.

3. Bidding will be conducted through open competitive bidding procedures using non-discretionary “pass/fail” criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
 - a. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183
4. Interested bidders may obtain further information from *Department of Public Works and Highways Regional Office VII* and inspect the Bidding Documents at the address given below from **8:00 A.M. to 5:00 P.M.**
5. A complete set of Bidding Documents may be acquired by interested bidders **July 03 - 23, 2025 until 10:00 A.M. only** from given address and website/s below upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **Php5,000.00**. The Bidding Documents may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS), and the website of the Procuring Entity, provided that bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

The Department of Public Works and Highways Regional Office VII will hold a Pre-Bid Conference on **July 11, 2025 at 10:00 A.M.**, Conference Room of BAC Office, Ground Floor, *DPWH-Regional Office VII, South Road Properties, Cebu City* and/or through Regional Office Official **YouTube Channel DPWH Regional Office VII Procurement LS or YouTube Handle: @DPWH.RO.7**, which shall be open to prospective bidders.
7. Bid submission will be done manually on **July 23, 2025 @ 10:00 A.M.** Late bids shall not be accepted.
8. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB Clause 14**.

Bid opening shall be on **July 23, 2025 at 10:30 A.M.**, Conference Room of BAC Office, Ground Floor, *DPWH Regional Office VII, South Road Properties, Cebu City* and/or Regional Office Official **YouTube Channel DPWH Regional Office VII Procurement LS or YouTube Handle: @DPWH.RO.7**. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.

The Department of Public Works and Highways Regional Office VII reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised Implementing Rules and Regulations (IRR) of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
