

WHEREAS, upon evaluation the Bids and Awards Committee (BAC) found out that Al-Sadik Construction & Enterprises, Inc. and Fusion Trading has "Not submitted Business Papers Information for Pre-qualification" which is a requirement in participating in procurement of goods. Therefore, Al-Sadik Construction & Enterprises, Inc. and Fusion Trading is disqualified.


WHEREAS, the ABSTRACT OF QUOTATIONS showed that among the suppliers who submitted their quotations, only **4S & N CONSUMER GOODS** complied with and was found responsive to the requirements under the Request for Quotation (RFQ) with the lowest calculated responsive bid, with items (goods) specifications acceptable to the Implementing Office/End-User Unit Concerned;

NOW THEREFORE, We, the members of the Bids and Awards Committee (BAC) for Goods resolves as it is hereby resolved to recommend the award of the contract for the procurement of said goods through Small Value Procurement in the total amount of **(P 914,000.00) (NINE HUNDRED FOURTEEN THOUSAND PESOS ONLY)** to **4S & N CONSUMER GOODS** which submitted the lowest calculated bid.
