## CONTRACT AGREEMENT

### KNOW ALL MEN BY THIS PRESENTS:

This AGREEMENT made the 19th day of August, 2024, between Department of Public Works and Highways - Zamboanga Sibugay 2nd District Engineering Office represented herein by **BENSALI A. KASIM**, duly authorized for this purpose with main office address at Tirso Babiera, Ipil, Zamboanga Sibugay, Philippines (hereinafter called "the Entity") of the one part and **RCJJ GENERAL MERCHANDISE** a private security agency, represented herein by **IRIS JASMIN T. LADLAD** of Purok Airways, Sanito, Ipil, Zamboanga Sibugay, Philippines (hereinafter called "the Supplier") of the other part;

**WHEREAS**, the Entity invited Bids for certain goods and ancillary services, particularly **24GJF0231 - ReflectORIZED Traffic Paint (White) (20ltrs./pail), Blown Asphalt, Grass Cutter (2 stroke) TD 40, Paint Brush 4", Thinner Paint and Biometric Machine for use in the repainting of bridges, crack and joint sealing and for use in the Maintenance Section, this district** and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **TWO MILLION SEVEN HUNDRED FIFTY-ONE THOUSAND SIX HUNDRED EIGHTY-EIGHT PESOS ONLY (P 2,751,688.00)** (hereinafter called "the Contract Price").

### NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- 1 In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.

  - b. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's-response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- c. Performance Security
- d. Notice of Award of Contract and the Bidder's conforme thereto; and
- e. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. **Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.**
