INVITATION TO BID FOR THE SUPPLY AND DELIVERY OF IT EQUIPMENT AND OTHER SUPPLIES FOR USE OF MALABON — NAVOTAS DISTRICT ENGINEERING OFFICE

- 1. The DPWH-NCR-Malabon Navotas District Engineering Office (MNDEO), through the FY 2025 General Appropriations Act (GAA) intends to apply the sum of Nine Million Nine Hundred Ninety Two Thousand Three Hundred Forty Three Pesos and 38/100 Only (₱ 9,992,343.38) being the Approved Budget for the Contract (ABC) to payments under the contract for Supply and delivery of IT Equipment and other supplies for use of Malabon Navotas District Engineering Office with Contract ID No. MNDEO-PB-031-2025. Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The DPWH-NCR-Malabon Navotas District Engineering Office (MNDEO), through its Bids and Awards Committee (BAC) for Goods now invites bids for the above procurement project. **Delivery of the goods is required within 120 calendar days upon receipt of the Notice to Proceed**. Bidders should have completed, within five (5) years from the date of submission and receipt of bids, a single contract similar to the project, equivalent to at least 50% of the ABC. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
- 3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
 - a. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.
- 4. Prospective Bidders may obtain further information from DPWH-NCR-Malabon Navotas District Engineering Office (MNDEO) thru its Bids and Awards Committee for Goods and inspect the Bidding Documents at the address given below from Monday to Friday at 7:00 AM to 4:00 PM.
- 5. A complete set of Bidding Documents may be acquired by interested Bidders on June 14, 2025 until before 10:00 AM of July 4, 2025 from the given address and website(s) below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Php. 10,000.00. The Procuring Entity shall allow the bidder to present its proof of payment for the fees in person or through electronic means.

- 6. The DPWH-NCR-Malabon Navotas District Engineering Office (MNDEO) thru its Bids and Awards Committee for Goods will hold a Pre-Bid Conference on June 23, 2025 at 9:00 AM at MNDEO BAC Conference Room, C4 Road, Bagumbayan North, Navotas City and will go live via youtube channel at https://www.youtube.com/@DPWH.MN DEO which shall be open to prospective bidders.
- 7. Bids must be duly received by the BAC Secretariat through manual submission at the office address indicated below, on or before **July 4, 2025 at 10:00 AM.** Late bids shall not be accepted.
- 8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 14.
- 9. Bid opening shall be on **July 4, 2025 at 10:00 A.M.** at **MNDEO BAC Conference**Room, C4 Road, Bagumbayan North, Navotas City and will go live via youtube
 channel at https://www.youtube.com/@DPWH.MN DEO. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
- 10. The DPWH-NCR-Malabon Navotas District Engineering Office (MNDEO) thru its Bids and Awards Committee for Goods reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
