INVITATION TO BID FOR

Contract ID No. 25GID0032– Supply and Delivery of Asphalt Instant Coldmix suitable for Item 309-Bituminous Plant Mix (Stockpile Maintenance Mixture) for use in the Maintenance of National Roads and Bridges within the 2nd District of Leyte, DPWH Leyte 2nd District Engineering Office, Mac Arthur, Leyte

1. The **DPWH, Leyte 2nd DEO, Mac Arthur, Leyte**, through the **Maintenance Fund CY 2025** intends to apply the sum of being the ABC to payments under the contract for **25GID0032-Supply and Delivery of Asphalt Instant Coldmix suitable for Item 309-Bituminous Plant Mix (Stockpile Maintenance Mixture) for use in the Maintenance of National Roads and Bridges within the 2nd District of Leyte, DPWH Leyte 2nd District Engineering Office, Mac Arthur, Leyte**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The **DPWH, Leyte 2nd DEO, Mac Arthur, Leyte** now invites bids for the above Procurement Project. Contract Duration is required for **15 days** and Approved for the Contract of **One Million Six Hundred Seventy Two Pesos Only (Php 1,672,000.00)**. Bidders should have completed, within **2 Years** from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
 - a. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.
 - b. Bidding is open to all interested bidders, whether local or foreign, subject to the conditions for eligibility provided in the 2016 revised IRR of RA No. 9184.
4. Prospective Bidders may obtain further information from **DPWH, Leyte 2nd DEO, Mac Arthur, Leyte** and inspect the Bidding Documents at the address given below during 8:00 A.M. -5:00 P.M.
5. A complete set of Bidding Documents may be acquired by interested Bidders on **June 13 to July 7, 2025 at DPWH, Leyte 2nd DEO, Mac Arthur, Leyte**. It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System

(PhilGEPS) and www.dpwh.gov.ph provided that Bidders shall pay the applicable fee of **Php 5,000.00** for the Bidding Documents not later than the **July 7, 2025 at 10:00 A.M.**

6. The **DPWH, Leyte 2nd DEO, Mac Arthur, Leyte** will hold a Pre-Bid Conference¹ on **June 24, 2025 @ 10:00 A.M** at **DPWH, Leyte 2nd DEO, Mac Arthur, Leyte**, which shall be open to prospective bidders.
7. Bids must be duly received by the BAC Secretariat through Manual Submission on or before **July 7, 2025 @ 10:00 A.M.** Late bids shall not be accepted.
8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 14.
9. Bid opening shall be on **July 7, 2025 immediately after the deadline of submission of bidding documents** at the given address below **DPWH, Leyte 2nd DEO, Mac Arthur, Leyte**. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
10. The **DPWH, Leyte 2nd DEO, Mac Arthur, Leyte** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
