**Invitation to Bid for The Procurement of Security Services for DPWH 2<sup>nd</sup> District Engineering Office (12 Security Guard - 1 Year) CY 2024**

1. The Department of Public Works and Highways-Misamis Occidental 2<sup>nd</sup> DEO, Sta. Maria, Tangub City through the **EAO 2023 Extended** intends to apply the sum of **Three Million Two Hundred Eighty-Three Thousand Six Hundred Seventy-Nine Pesos & 52/100 (Php 3,283,679.52)** being the **Approved Budget for the Contract (ABC)** to payments under the contract for **Purchase Request No. 2024-01-0001** dated January 11, 2024. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The Department of Public Works and Highways-Misamis Occidental 2<sup>nd</sup> DEO, Sta. Maria, Tangub City now invites bids for the **24GSKJ0001: Procurement of Security Services for DPWH 2<sup>nd</sup> District Engineering Office (12 Security Guard - 1 Year) CY 2024, DPWH Misamis Occidental 2<sup>nd</sup> DEO, Sta. Maria, Tangub City**. Bidders should have completed, within five (5) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass-fail" criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act."

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183 and subject to Commonwealth Act 138.

4. Interested bidders may obtain further information from the *Department of Public Works and Highways- Misamis Occidental 2<sup>nd</sup> DEO, Sta. Maria, Tangub City* and inspect the Bidding Documents at the address given below during weekdays *from 8:00AM-5:00PM*.

A complete set of Bidding Documents may be purchased by interested Bidders on **January 19, 2024** until before noon of **February 9, 2024** from the address below and upon payment of a nonrefundable fee for the Bidding Documents in the amount of **Five Thousand Pesos (P5,000.00)**.

It may also be downloaded free of charge from the websites of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the nonrefundable fee for the Bidding Documents not later than the submission of their bids.

5. The *Department of Public Works and Highways- Misamis Occidental 2<sup>nd</sup> DEO* will hold a **Pre-Bid Conference** on **January 29, 2024, 10:00 a.m.** at DPWH Building, Sta. Maria, Tangub City, which shall be open only to all interested parties who have purchased the Bidding Documents.
