## INVITATION TO BID

- 1. The DPWH, Negros Oriental 3<sup>rd</sup> District Engineering Office, Siaton, Neg. Or. thru its Bids and Awards Committee (BAC) for Goods, through the GAA 2025 R.A. 12116 intends to apply the sum of Two Million Two Hundred Eight Thousand and 00/100 pesos only (Php 2,208,000.00) being the Approved Budget for the Contract (ABC) to payments under Contract ID No. 25GRI0005. Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The DPWH, Negros Oriental 3<sup>rd</sup> District Engineering Office, Siaton, Negros Oriental now invites bids for the Procurement Project listed below:

Delivery of the Goods is required as specified in the Schedule of Requirements. Bidders should have completed, within two (2) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.

3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.

- 4. Prospective bidders may obtain further information from the DPWH, Negros Oriental 3<sup>rd</sup> District Engineering Office, Siaton, Neg. Or. thru its Bids and Awards Committee for Goods and inspect the Bidding Documents at the address given below from Monday to Friday at 8:00 AM to 5:00 PM.
- 5. A complete set of Bidding Documents may be acquired by interested Bidders on <u>April 4, 2025 until 4:00 P.M. of April 22, 2025</u> from the given address or website(s) and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, depending on the total ABC of the items to be bid by the bidder. - Bids must be duly received by the BAC Secretariat through manual submission at the address indicated below <u>on or before 10:00 A.M. on April 23, 2025</u>. Late bids shall not be accepted.
- 8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 14.
- 9. GPPB Resolution No. 15-2021 dated October 14, 2021, provides that failure by the bidder to update its PhilGEPS Certificate of Platinum Membership with the current and updated Class "A" Eligibility Documents covered by Section 8.5.2 of the 2016 Revised IRR of RA 9184 shall result in the automatic suspension of the validity of its certificate of Platinum Registration and Membership.
- 10. **Bid opening shall be at** <u>10:00 A.M. on April 23, 2025</u> at the given address below. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
- 11. The DPWH, Negros Oriental 3<sup>rd</sup> District Engineering Office, Siaton, Neg. Or. thru its Bids and Awards Committee for Goods reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contact award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
