BAC RESOLUTION DECLARING CANCELLATION OF PROCUREMENT ACTIVITIES OF CONTRACT ID NO. 24GOH0040- PURCHASE OF ASPHALT MATERIALS FOR THE REPAIR AND MAINTENANCE OF NATIONAL ROADS WITHIN SMDEO JURISDICTION

## **RESOLUTION NO. 014-2025**

**WHEREAS,** the Department of Public Works and Highways-South Manila District Engineering Office advertised the Invitation to Bid for the above stated Contract at the website of the DPWH and the PhilGEPS and at a conspicuous place at the premises of the Department of Public Works and Highways continuously for seven (7) calendar days starting on **June 6, 2025**;

WHEREAS, the said project has an Approved Budget for the Contract (ABC) amounting to Four Million Nine Hundred Thirty Eight Thousand Five Hundred Pesos Only (PhP P 4,938,500.00);

**WHEREAS,** there was additional Scope of Works incorporated in the Program of Works resulting in changes in the Approved Budget for the Contract (ABC) of the above-mentioned project;

**WHEREAS**, the Bids and Awards Committee unanimously agreed to declare the cancellation of procurement activities due to revision of the program of works;

**WHEREAS**, pursuant to Section 35.6 of 2016 Revised IRR of R.A. 9184 which provides that without prejudice to Sec. 35.1 hereof, the BAC is authorized, upon consultation with the end-user unit, to cancel or terminate the conduct of procurement activities, **for any justifiable reason**, **such as but not limited to**: a) the physical and economic conditions have significantly changed so as to render the project no longer economically, financially, or technically feasible, as determined by the end-user unit; b) the project is no longer necessary as determined by the end-user unit; c) the source of funds for the project has been withheld or reduced through no fault of the PE; or d) brought about by the declaration of a State of Calamity, or implementation of community quarantine or similar restrictions.

**NOW, THEREFORE,** we, the Members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED that the above-mentioned project be cancelled.
