**RESOLUTION OF THE REGIONAL BAC, DPWH, REGION VI, ILOILO CITY TO  
DECLARE FAILURE OF BIDDING AND TO RE-ADVERTISE CONTRACT ID NO.  
25GG011 – PROCUREMENT OF ONE (1) MULTIFUNCTION COLOUR INKJET  
PHOTOCOPIER AND INKS FOR USE IN THE FINANCE DIVISION, DPWH  
REGIONAL OFFICE VI, ILOILO CITY**

**BAC RESOLUTION**

**WHEREAS**, the Government of the Philippines (GOP), through the Department of Public Works and Highways (DPWH) intended to apply the sum of Php 909,974.00 being the Approved Budget for the Contract (ABC) for **Contract ID No. 25GG011 Procurement of One (1) Multifunction Colour Inkjet Photocopier and Inks for use in the Finance Division, DPWH Regional Office VI, Iloilo City** which was posted in the PhilGeps, DPWH website and in conspicuous places in the DPWH Regional Office VI last April 2-8, 2025;

**WHEREAS**, the aforementioned procurement was requested by Chief, Finance Division to be procured through public bidding, submission and opening of bids was scheduled on April 24, 2025;

**WHEREAS**, in response to the said advertisement, three (3) bidders, ISOURCE ASIA BUSINESS SOLUTIONS CORPORATION, GAKKEN PHILIPPINES INC., and COCCYX COMPUTER SALES AND SERVICES purchased bid documents for the said bidding;

**WHEREAS**, there was a failure of bidding for the aforementioned procurement since the technical specifications offered by the three (3) eligible bidders, failed to met the required minimum technical specifications;

**WHEREFORE**, in consideration of the foregoing premises, the herein Bids and Awards Committee (BAC) Resolves as it is hereby Resolved to declare failure of bidding and to re-advertise Contract ID No. 25GG011- Procurement of One (1) Multifunction Colour Inkjet Photocopier and Inks for use in the Finance Division, DPWH Regional Office VI, Iloilo City in consonance with Section 35.1 (a) and 21.2 of the RIRR.


