WHEREAS, the DPWH Davao Oriental First District Engineering Office posted on July 3, 2025 the INVITATION TO BID for Contract ID. 25GLF0044 – Supply and deliver of materials and consumables for the repair/maintenance of one (1) unit photocopier machine of Quality Assurance Section DPWH First DEO, Baganga, Davao Oriental, with an Approved Budget for the Contract (ABC) of Php275,634.32 in the DPWH Website, the PhilGEPS, and conspicuous place in the premises of the DPWH continuously for seven (7) days;
